To our Campground Seasonal Guests,

What a SURPRISE!! Fair Havens Ministries will OPEN our seasonal campground sites this Saturday, May 16th, in accordance with the Provincial guidelines, announced yesterday. The campground gates will OPEN at 9 AM on Saturday... DO NOT come up FRIDAY NIGHT... the Campground will be LOCKED. We look forward to welcoming your family back to Fair Havens!

The water and hydro utilities have been turned on for the Season Site campground sites; although we have not been able to verify all of the connections nor if there are any leaks. As well, as you can imagine, due to the provincial activity restrictions that have been in place, we have not been able to get our grounds and facilities up to our usual standards for this time of the year. We appreciate your patience as we work to catch up! AS WELL, please know that we have 14 Staff on Lay-Off and ONLY TWO Maintenance Men working part-time to do the many duties to OPEN up. Please refrain from having them work on your site &/or trailer.

For the safety of guests and staff, and to comply with provincial COVID-19 regulations, the following measures are in place. We will keep you updated as measures change over the course of the season:

**Risk Waivers:**

- Each seasonal trailer owner is required to fill out a waiver, acknowledging the risks and safety protocols associated with COVID-19. They will be available from the Office.
- If you rent your trailer, you must email us (lthompson@fairhavens.org) with names, email address and cell phone number of anyone using the trailer other than the registered owner and their immediate family. This is required for tracing purposes in the event of an occurrence of COVID-19 on the grounds.
- Each renter or visitor must also fill out a waiver. We reserve the right to refuse access until we have a completed waiver on file.
- ALL PERSONS over 18 years MUST sign a waiver.
- Parents/Guardians must sign a waiver on behalf of their (named) minors under the age of 18 years.

**The following areas are closed at this time**, to comply with provincial restrictions:

- Nightly camp sites (transient)
- Public washrooms & showers
- The Riverside Inn, Dining Room, Fireside Room, Heritage Hall, Café, Chapel
- Fair Havens beach for swimming and transient campground areas
- We will not be able to hold in-door chapel services, children nor youth programs

**Restrictions on gatherings:**

- The rules regarding gathering that apply at your home will also apply at your trailer – no visitors, one family only on the trailer site, group gathering size is limited to 5 (other than your immediate family members).
- Controlled campfires are permitted by the municipality and the province.
- You are welcome to walk anywhere on the grounds or across the road onto our OCE trailers, but please observe 6-foot distancing guidelines as you meet your friends and neighbours in your travels.

**The following areas are open during the week from 10am to 2pm:**

- The Main Office will be open by appointment to make payments. Call 705-341-6345 to reach Liz Thompson.

We are excited to be able to open the seasonal Campground, and we are looking forward to opening other areas of Fair Havens as provincial restrictions allow. We are praying that God will provide for a safe and fruitful season of Ministry at Fair Havens. We look forward to seeing your family!

# COVID-19 ACKNOWLEDGEMENT AND ASSUMPTION OF RISK

1. I agree to abide by the current restrictions and regulations as outlined by the Government of Ontario and/or Ontario Public Health as well as the COVID-19 safety protocols of Fair Havens. As well as observing & complying with Social/Physical Distancing guidelines for my self, I will also assure that my children under the age of 18 years observe these said guidelines in all areas of the Fair Havens Property.
2. I am not currently experiencing COVID-19 symptoms nor have I had COVID-19 symptoms in the last 14 days.
3. I have not travelled outside of Canada or in an area under a travel health advisory in the last 14 days.
4. I have not provided care or had close contact with any person with COVID -19 or with any person reasonably suspected to have COVID -19 or with any person who travelled outside of Canada in the last 14 days or with any person who travelled in an area under a travel health advisory in the last 14 days.
5. I represent and warrant to Fair Havens Ministries that I have not been advised by the Government of Canada or Ontario Public Health or my doctor or the Ontario Ministry of Health website to self-isolate due to possible exposure to COVID -19.
6. I represent and warrant that I will advise Fair Havens Ministries immediately if any person in our party or any person visiting us on the Premises has been exposed to COVID-19 or has contracted COVID-19, and further that I will follow any direction from Fair Havens' Management or health authorities as it relates to leaving the Premises or isolating on the Premises as a result of COVID-19 exposure or infection.
7. I am fully aware of the risks and hazards with respect to COVID-19 inherent in my attendance at the Fair Havens Bible Centre and participation in the activities of Fair Havens.
8. I freely and voluntarily agree to assume the risk with respect to COVID 19, including the risk of death or bodily injury, regardless of severity, that I (or my child/ward) may sustain as a result of my participation in the activities of Fair Havens or attendance at Fair Havens, howsoever arising, including, but not limited to, the active or passive negligence of the Releasees.
9. If my stay at Fair Havens is cut short due to contracting COVID-19, then I agree not to request any adjustment in fees nor cancellation refunds.

By placing my signature below, I confirm that I understand that there are inherent and unforeseen risks involved in participating in the activities of Fair Havens Ministries or while attending the Premises.

I have read this document in its entirety and fully understand its terms. I understand that I am giving up substantial legal rights by signing below, including the right to sue the Releasees. I acknowledge that I am signing this agreement freely and voluntarily and intend my signature to be a waiver and complete and unconditional release of all liability due to the negligence of the Releasees or, the inherent risks of participating in the activities of Fair Havens or while attending the Premises.
